**Over the Moon Rules and Restrictions**      **\*\*\*Must be adhered to at all times to maintain safe use\*\*\***

1. There must be adult supervision of any Over the Moon Bounce at all times.
2. Children of approximately the same age and size should play at the same time.
3. The maximum number of bouncers will vary depending on their age as listed below (exact number for the Bounce you rent will be given to you by the Over the Moon delivery representative):

Age Group:	2-4 yrs. old	5-8 yrs. old	9-12 yrs. old	13-18 yrs. old	Adults

4. At no time are any bouncers to climb on the walls inside or outside of the Bounce.
5. Do not allow your guests to attempt flips while using the Bounce.
6. Absolutely NO SHOES, SHARP OBJECTS, OR FOREIGN ARTICLES/SUBSTANCES are allowed in the Bounce.
7. Absolutely NO FOOD, GUM, CANDY, or DRINKS are allowed in the Bounce at any time.
8. Absolutely NO PETS allowed on the Bounce at any time.
9. All bouncers are playing at their own risk.

**Cleaning, Damages and Replacement**

1. Any Bounces returned that require cleaning over and above regular disinfecting will incur an additional \$50 cleaning charge payable at the time of pickup.
2. If any Bounce is damaged through negligence or not following the rules above and is returned in such a condition that it cannot be adequately repaired for safe rental usage, the lessee agrees to pay the full replacement value of the Bounce equipment in question.

**RELEASE of LIABILITY & ASSUMPTION of RISK**

In consideration of being permitted to use the Over the Moon Bounce equipment, the undersigned acknowledges and agrees to the following:

1. Participants will abide by all policies and procedures set out by Over the Moon Bounce & Party Rentals Ltd. in the Rental Agreement;
2. Risks and dangers exist during jumper/bouncer activities. These risks include physical injuries, psychological injuries, and even the possibility of loss of life;
3. Each person is responsible for his/her actions and those of his/her children and guests on and around the Over the Moon Bounce and agrees to abide by all posted rules, policies, and procedures in order to maintain the utmost level of safety;
4. I hereby assume all of the risks of participating in the jumper/bouncer activities and will hold the owner/operator and its employees, agents, officers, trustees, and affiliates harmless from any and all liability, actions, demands, damages, expenses, costs, claims and causes of action of any possible nature in respect to injury, death, loss, or damage to myself, child, or property however caused as a result of or in any way relating to my activities in and around the Over the Moon Bounce equipment;
5. I further agree to indemnify and hold harmless the owner/operator, its employees, agents, officers, trustees, and affiliates from and against any and all liability incurred as a result of or in any manner related to my participation and rental of Over the Moon Bounce equipment and the jumper/bouncer activities of all participants while in the possession and/or control of the lessee;
6. If, despite the signing of this waiver, a lawsuit is brought against the owner/operator, its employees, agents, officers, trustees, or affiliates in relation to participation in the jumper/bouncer activities, I agree to pay for any and all court costs and attorneys fees incurred as a result of such litigation;
7. I also declare that neither I nor my children, if applicable, are under the influence of any chemical substance including alcohol at the time of the signing of this release or at the time of participation in the jumper/bouncer activities;
8. I agree that if any provision of this release is found to be unenforceable or invalid in any way, the remaining provisions will remain in force and effect;
9. I fully understand that jumper/bouncer activities involve a certain level of risk of injury. My participation in these activities and my signing of this waiver are completely voluntary.
